 - --Worship Supplement (1969), Contemporary Worship (1969-1976), Lutheran Book of Worship (1978), and Lutheran Worship (1982)
- p.249 As early as 1956, the Intersynodical Committee was urging a revised edition of TLH p.250 1959 LCMS Convention reported the Synod didn't want a revised edition.

- p.250 1965 Detroit Convention laid out plans for a revised edition of TLH completed by 1970
- p.251 Philip Pfatteicher's official history contradicts Precht's report of Synod's new support LCA and ALC got Missouri to initiate a request of cooperation with other churches.
- p.253 1966 ILCW formed, at the time of LCMS President Oliver Harms
 - -By 1969 had produced 10 booklets entitled Contemporary Worship
- p.254 The International Consultation on English Texts (Lord's Prayer, Te Deum)
- p.256 Worship Supplement (1969)
 - --appeared in time for use at the Denver LCMS Convention (1969)

Part III. The ILCW and the Lutheran Book of Worship (1979)

- p.261 The 1965 LCMS Convention (Detroit) authorized a cooperative hymnal venture
- p.261 Commission on Worship, Liturgics, and Hymnody(CWLH) worked secretly
- p.262 April 1963 long-range goals Unity or Unionism
 - --To bring together the National Lutheran Council (NLC, 1918- 1967) made up of ALC, LCA --and the Synodical Council (SC) of LCMS, WELS, etc. not part of NLC
 - Note 1: In 1967 the LCUSA replaced the NLC, the LCMS joined it but then withdrew in 1977.
 - Note 2: The LCMS was in fellowship went into fellowship with ALC in 1969
 - p. 263, "The use of one book encouraged and facilitating the merging of church bodies."
- p.264 Actually the committee was working toward a new book (not the original project)
- p.265 the goal of a universal hymnal in 1980.
- p.266 Ecumenical and modernist assumptions resulting in a different spirit. Hoping the name "Lutheran" would not be a part of the title. Implications of WCC's *Baptism*, *Eucharist and Ministry* document.
- p.268 Lutheran Book of Worship (LBW 1978)
- p.268 Language of Worship
- p.269 "away from philosophical language and toward evocative images"
- p.270 "It is another way of doing theology and a better way of doing liturgy."
- p.271-272 A number of issues regarding language, etc.
- p.273-277 STRUCTURE of LBW
- p.277 LCMS fellowship with ALC was beginning to fall apart in 1977 ("fellowship in protest")
- p.277-278 July 1977 LCMS Convention (Dallas) did not accept LBW and 6 of the 7 members of the Commission on Worship resigned. In 1979 the synod resolved to publish its own hymnal, **Lutheran Worship** (1982).

Part IV. Lutheran Worship (1982).

- p.281 LCMS Synodical Presidents: Jack Preus (1969-1981), Ralph Bohlmann(1981-1992)
- p.282 Lutheran Worship turned LCMS into a three hymnal synod.
- p.282 By 1989, approximately 250 LCMS partishes a year were abandoning the use of hymnal."
- p.282 "In this regard, LW is not as radical as LBW, which abandoned both the 'Common Service' and the 1958 'Common Liturgy."

p.302 Five separate Divine Services in the LSB

p.303 Divine Service Setting III is astonishingly the "Common Service" with modifications.

p.304 efforts to modernize the language did not draw significant LCMS interest

p.305 in 1999, 53% of LCMS congregations had TLH available, and 36% were still regularly using it, though Lutheran Worship (1982) has been published 18 years earlier.

p.305-309 – in 2003, the Committee finally abandoned the updated language version.
